# Accomplishments:

Consequently, vide the bi-annual Court Plenary, the court's judges are engaged in general policy formulation and planning.

### Accomplishments:

I contributed to the expeditious delivery of justice and reduction of case backlog – at the commencement of my tenure in the Land Division in August 2013 I had been allocated 504 cases, some of which dated back to 1981! This number continually increased with new case filings. By the end of May 2015 when I left the Division to take on my current assignment, 225 suits were completed (judgments and rulings delivered), 277 were at various stages of hearing, and all cases filed before 2005 had been concluded.

In collaboration with Pepperdine University – USA, conducted a pilot plea bargaining court session in respect of juvenile offenders.
